Lighting Agreement

Sports Interiors, Inc., ("SI"), and the "Client", Sterling Park District hereby agree to the following terms and conditions for the consideration hereinafter named.

Payment

SI shall perform the Scope of Work set forth below in consideration for the payment by Client of the sum of Ninety Two Thousand Three Hundred Ninety & 00/100 Dollars (\$92,390.00).

Payment Terms

Total project cost **\$92,390.00** will be billed on completion of project. Terms are net 15 days with a maximum of 30 days from the date of invoice. 1.5% interest per month charge will be added if past due.

Scope of Work

1. SI will provide and install 112 Sports Interiors LED Light Fixtures.
2. SI will utilize existing conduit and wiring from the current electrical breaker system and provide new conduit and wiring to complete installation of fixtures.
3. SI will provide and install control systems to turn on the tennis courts from the control desk.

Client's Responsibilities

The Client shall be responsible for providing SI access into building for lifts, equipment and inside storage for all materials and equipment during the project.

Excluded

SI's works shall not include the following, which shall be the responsibility of client: Permit and permit fees.

Insurance

SI will purchase and/or maintain Workers Compensation and General Liability Insurance at current levels, and SI will provide Client with a certificate of insurance prior to start of project.

Miscellaneous

The parties agree (1) this agreement may be signed in counterparts, (2) a fax or email signature may substitute as an original, (3) this agreement shall be construed and enforced in accordance with the laws of the State of Illinois, and (4) the person signing below has authority to bind the party on whose behalf he or she is signing and the terms and conditions herein are binding on the respective parties.




